# AGE OF MAJORITY TRANSFER FORM

### Instructions

- If you are a minor who has reached the age of majority in the state in which you reside, use this form to retitle a custodial
  investment in your name alone. We will validate age of majority requirements in the state in which you reside prior to processing
  this form. Once the form is processed, a new IncomeDriver Note<sup>™</sup> number will be established and the investment balance of the
  current custodial investment will be transferred to the new IncomeDriver Note<sup>™</sup>. A confirmation statement will be mailed to the new
  address of record when the new investment account is opened.
- Complete this form and provide a copy of one of the following to substantiate your age: a Birth Certificate or a valid and nonexpired U.S. Driver's License, U.S. State ID, Passport or Passport Card.

#### Please read and sign this section in blue or black ink.

- You authorize Toyota Motor Credit Corporation and its agents to initiate debits and credits to the linked bank account to
  implement funds transfers by the methods you have requested. The bank that holds the registered owners' checking or operating
  account ("Bank") is also hereby authorized to honor these debits and credits. All funds transfers (under the services) will comply with
  U.S. Federal and State law and where applicable, NACHA rules, the rules of the automated ACH clearinghouse. You may terminate this
  funds transfer authorization by providing written notice to Toyota Motor Credit Corporation but your notice will be effective
  only after Toyota Motor Credit Corporation and your Bank have a reasonable opportunity to act on your notice.
- You certify that you have received the prospectus and a copy of the IncomeDriver Note™ privacy policy.
- You understand that to comply with federal regulations, information provided by you on this form will be used to verify your identity. For example, identity may be verified through the use of a database maintained by a third party and, as part of normal investment verification procedures, a credit bureau inquiry will be conducted (this will be for identity verification purposes only; your credit report will not be pulled). If your identity cannot be verified, you understand that you may be required to provide additional information, and that your investment may be closed, and redeemed, if verification is still not possible in a timely manner. Such redemptions may have tax consequences.
- You understand that an investment is not equivalent to a deposit or other bank account and is not subject to the protection of the Federal Deposit Insurance Corporation or any other insurance.
- An investment is not a brokerage account with Toyota Motor Credit Corporation or any other broker/dealer and is not protected by the Securities Investor Protection Corporation under the Securities Investors Protection Act of 1970. #### Under penalties of perjury, I certify that:
